In September 2014 Shperov was elected to the State Council of the so-called 'Republic of Crimea. He has publicly admitted, including in an interview published on Idpr-rk.rk website on 3 September 2016, his role in the events of 2014 that led to the illegal annexation of Crimea and Sevastopol and in particular his role in the organisation of the illegal referendum of the peninsula.
